**Summary of training and experience:** I have a bachelor's degree in psychology and master's and Doctoral degrees in clinical psychology. I graduated with honors at both the undergraduate and graduate level and have extensive research experience with adolescents and their families. I have been in clinical practice for thirty years, specializing in the psychological assessment and treatment of adolescents and adults. I am on the faculty of the psychology department at Pacific University where I have taught and currently supervise psychologist residents and advanced doctoral students who are preparing to specialize in forensic psychological evaluations and treatment. I have written articles and presented in numerous areas related to forensic evaluations, including women who commit criminal offenses, white collar crime, Posttraumatic Stress Disorder, domestic violence, competency, and other topics related to forensic psychology. I maintain an active clinical practice along with my forensic psychology practice.

After extensive advanced training, I have conducted forensic psychological evaluations for eighteen years, almost exclusively in cases involving individuals who are charged with serious crimes. I am a Certified Forensic Examiner in Oregon and I specialize in evaluations in complex cases, especially those that involve individuals who are cognitively or psychologically impaired or vulnerable in some way. I have conducted over 500 forensic psychological evaluations of criminal defendants. Many of the evaluations that I conduct are for purposes of sentencing mitigation and competency questions as well as mental state at the time of an alleged offense. I have been qualified in both federal and state court. In my forensic evaluations, my goal is to provide objective, thorough and accurate information to the trier of fact irrespective of who has asked me to perform the evaluation. In this effort I rely on both established and current research literature that is relevant to the psycholegal question and make every effort to provide information that is useful to the Court, including defense attorneys, prosecutors and judges.
